A RESOLUTION OF THE WEST MANATEE FIRE AND RESCUE DISTRICT OF MANATEE COUNTY, FLORIDA; PROVIDING A SCHEDULE FOR USER SERVICE FEES TO BE COLLECTED BY THE DISTRICT AND MUNICIPALITIES PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the West Manatee Fire and Rescue District ("District"), pursuant to the provisions of Section 191.006(11), Florida Statutes (F.S.), has authority to charge user fees authorized by resolution of its Board of Fire Commissioners ("Board"), in amounts necessary to conduct district activities and services, and to enforce their receipt and collection in the manner prescribed by resolution and authorized by law; and


WHEREAS, pursuant to Section 191.009(3)(d), F.S. the Board may provide a reasonable schedule of charges for inspecting structures, plans, and equipment to determine compliance with fire safety codes and standards;

WHEREAS, the Board of Fire Commissioners held a properly advertised meeting on August 18, 2016 in accordance with Section 189.015, Florida Statutes; and


NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners of West Manatee Fire and Rescue District that:



USER SERVICES FEE SCHEDULE

Pursuant to resolution 2016-09 effective August 18, 2016, West Manatee Fire and Rescue District will initiate a user services fee for all plans submitted to this department for review, as well as a field inspection fee. Fees shall be:

1. PLANNING & DEVELOPMENT RELATED SERVICES

This will include, but not be limited to the reviews of plans, permits, and inspections for:

- Emergency Fire Apparatus Access:
 - Roadways
 - Turnarounds
 - Emergency Access/Fire Lanes
 - Automatic Gates that do not require a building permit
- Water Supply Requirements:
 - Hydrants
 - Minimum Flow Requirements
- Fire Sprinkler/Standpipe Requirements
 - Point of Service
 - Backflow Devices
 - Fire Department Connection (FDC)

a. Development of Reginal Impact (DRI)- \$500.00

b. General Development/Site Plan Submission includes:

General Development Plans-	\$250.00
Preliminary Site Plans-	\$250.00
Final Site Plans-	\$250.00
Administrative Permits-	\$250.00
Special Permits-	\$250.00
Off Street Parking-	\$250.00

(The \$250.00 fee includes the initial plan submission and all subsequent revisions)

2. BUILDING AND DEMOLITION RELATED SERVICES

This will included, but not be limited to the reviews of plans, permits, and inspections for:

- Building
 - New construction
 - Renovations
 - Remodels
 - Demolition
 - Tents
 - Temporary Use
- a. Building/Demolition/Tent/Temporary Use permit submission- \$65.00
- b. Each plan re-submittal (incomplete application or previously denied plan)- \$115.00
- c. Work conducted without a permit (in addition to initial review fee)- \$195.00

3. FIRE PROTECTION SYSTEM RELATED SERVICES

This will include, but not be limited to the reviews of plans, permits, and inspections for:

- Fire Sprinkler Systems:
 - Underground
 - Aboveground
 - Other Suppression Systems:
 - Cooking/Hood
 - Fire pump/Standpipe
 - Clean Agent
 - Fire Alarm System
- a. Fire Protection System submission- \$115.00
- b. Consultation/Pre-construction review/Courtesy review- \$65.00
- c. Each plan re-submittal- \$115.00
(Incomplete application or previously denied plan)
- d. Work conducted without a permit- \$345.00
(in addition to initial review fee)
- e. Initial system field acceptance test- No Charge
- f. Each system field acceptance re-test- \$125.00
(Must be paid PRIOR to scheduling the re-test)
- g. Fire Hydrant flow data requiring field testing or witnessed flow Test-site visit \$100.00

4. CERTIFICATE OF OCCUPANCY RELATED SERVICES

This will include, but not be limited to the final inspections of the following in order to receive a Certificate of Occupancy (CO) by Manatee County.

- Compliance with approved plans
- Fire Protection Systems documentation
- Life safety features
- Exit and emergency lighting
- Egress systems

- Fire Extinguishers
- Addressing numbers
- Rapid entry systems

6. STANDBY SERVICES

This will include, but not be limited to the provision of Fire District personnel and equipment for:

- Required standbys:
 - Fire watch
 - Incidents
 - Events
- Requested standbys
 - a. Equipment costs - current F.E.M.A. Schedule of Equipment Rates
 - b. Personnel cost- per Fire District employee pay and benefits rates
 - c. Supply cost – the actual replacement cost for any supplies used

*****The Fire Marshal shall waive the fee for all publicly noticed fireworks displays which are printed prior to the display in a daily or weekly newspaper and/or a minimum of 3 days prior in an associated newspapers' website for the benefit of the general public which does not constitute an undue burden on the District. Private citizen displays not advertised as noted above would also be exempt from the fee on Independence Day (July 4th) and New Years Day (January 1st). Nothing herein exempts any person, municipality, or business from obtaining the proper authorization from the Fire Marshal prior to the display to the display of fireworks at any time.
